1. Scope

All government entities within the state of Alaska, including all state agencies and local public purchasing units, including cities/boroughs, school districts, and universities, are authorized to purchase products and services under the terms and conditions of the price agreement.

2. Changes:

- A. **Default:** In case of material default by the Contractor, for any reason whatsoever, the State of Alaska, after express written notice to the Contractor which provides a description of the default and allows for a reasonable period of time for the Contractor to attempt to cure such default, may procure the goods or services effected by the uncured default from another source and hold the contractor responsible for any reasonable and customary resulting costs arising from the reprourement actually incurred by the State of Alaska and may seek other remedies under law or equity.
- B. The reporting format shall be as follows: On at least a quarterly basis, Hewlett-Packard Company will supply the State of Alaska with an electronic usage report, which will list the purchasing entity, description of item(s) purchased, date, dollar amount, retail price, and extended price for each transaction.




