1. Scope

The State of Florida Department of Management Services (the "Department") is authorized by Section 287.042(16), Florida Statutes, to evaluate contracts and, when determined in writing to be cost-effective and in the best interest of the State, to approve such contracts for use by other entities.

The Department hereby grants all Eligible Users (as that phrase is defined in s. 60A-1.005, F.A.C.) permission to make purchases under this Contract. Notwithstanding this blanket approval for eligible users, agencies (as defined in s. 287.012(1), F.S.) must seek approval from the Department before making purchases from this alternate contract source. Agencies shall seek such approval by following the process established by Rule 60A-1.047, F.A.C.

2. Changes:

[None, for non-agency eligible users. If an ordinance, rule, or other local governmental authority requires additional contract language, the eligible user is responsible for signing a separate Participating Addendum with the Contractor. Additional terms shall apply to any agency approval granted to an agency pursuant to Rule 60A-1.047, F.A.C.]


Orders and payments are to be handled by HP directly.

The terms and conditions of this Addendum and the Price Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.


