1. Scope

CIESC seeks to make the terms and prices of this Master Price Agreement #A63309 available to other education institutions located in Indiana. Extension of the terms and prices to any or all other Indiana education institutions is at the discretion of HP.

HP shall further understand and agree that participation by other education institutions is discretionary on the part of these institutions, and that CIESC bears no financial responsibility for any payments due HP by such entities, nor will CIESC be responsible for contract administration for other institutions.

2. Changes:

A. State of Indiana laws apply.

B. Quarterly reports are required to be submitted to the Primary Contact in the HP standard format. If applicable, HP agrees to reformat reporting as requested and as mutually agreed.

Terms and conditions inconsistent with, contrary or in addition to the terms and conditions of this Addendum and the Price Agreement, together with its exhibits, shall not be added to or incorporated into this Addendum or the Price Agreement and its exhibits, by any subsequent purchase order or otherwise, and any such attempts to add or incorporate such terms and conditions are hereby rejected. The terms and conditions of this Addendum and the Price Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.
