1. Scope

All State and local government entities, institutions of higher education, and school districts within the State of Louisiana are authorized to purchase products and services under the terms and conditions of the Western State Contracting Alliance Master Price Agreement with Lexmark International, Inc. and this Participating Addendum.

2. Changes:

- A. Louisiana Procedures: The Louisiana Procedures listed below are incorporated into this Agreement. In the event the referenced Louisiana Procedures and the Agreement conflict, the Louisiana Procedures will prevail:
1. Procedures for the Establishment and Continuance of a Brand Name Microcomputer Contract (Revised (2/28/00)
 2. Website Internet Catalog Purchasing Information (Revised 11/24/99)
 3. Software Purchases must be compliant with R.S. 39:199D and LAC Title 34, Chapter 55, Section 5505.
- B. Delete third paragraph under "Intent and Purpose" in its entirety. Professional services will not be applicable to this agreement.
- C. "Take Back Program" will not be applicable to this agreement.
- D. Under Section 6, Payment Provisions:
Change last sentence of Section B, Payment of Invoice, Paragraph 2 to read:
Payments may be made via a Purchasing Entity's Purchasing Card" in accordance with the rules and regulations governing its use.
- E. Under Section 17, delete all references to Take Back and Recycling programs.
These programs are not applicable to this agreement.
- F. Change Section 56, Value Added Services, change title to read "Services".
Delete the last sentence which refers to additional Value Added Services in its entirety.

- G. Delete Exhibit C in its entirety. The State of Louisiana will review the Value Added Services being offered in this Exhibit and will consider adding these services at a later date through another Participating Addendum.

The terms and conditions of this Addendum and the Price Agreement and its exhibits shall prevail and govern in the case of any such inconsistent or additional terms.
